25 Years Later - Two Reports Filed

A couple of Fermi's License Events that happened in August 1995 finally made it into the NRC public library. Both evolved from a 10-day series of events organized by nuclear abolitionists.

One notice which happened August 5th, was the arrest of three people who used a ladder to climb the fence and enter Fermi's grounds.

The other happened on August 9th and involved two members of Greenpeace scaling Fermi's north cooling tower and hung a No Nukes banner.

Protecting Our Earth from Fukushima to Fermi 2

March 11th makes 10 years since the Fukushima disaster began; it has not yet been stabilized. CRAFT will commemorate the disaster on the day, and days leading up to March 11.

We carry the ties to the terrible accident, not only by shared earth, but also by way of a shared reactor model with the same fatally flawed designs. Not only is Fermi 2 the same Mark 1 design, but the world's largest at that.

At this crossroads in time, we see 10 years since the Fukushima meltdown as 10 years of evidence against Mark 1 reactors and nukes in general. We would also like people to see 10 years of growth in renewable development and generation capacity.

NRC Denies CRAFT Appeal

One year ago, CRAFT filed for a public hearing on DTE's plan to use Snap-In neutron absorbers in Fermi's Spent Fuel Pool instead of removing and replacing the existing degraded neutron absorbers as they previously committed to do.

DTE lawyers and NRC Staff lawyers both filed to object saying CRAFT had no right to a public hearing. We appealed and gained a phone hearing to present Oral Arguments before an Atomic Energy and Licensing Board (ASLB).

After a few more filings and clarifications, the ASLB ruled we had no right to a public hearing. The only option left to us was to appeal to the full NRC – which we did.

As expected, the Commission denied our appeal, saying things like we were not allowed to introduce any new evidence, we were only allowed to prove the NRC wrong. Sad.

This NRC filing shows how much the NRC protects the nuclear industry. They ruled that we did not get a formal exemption to criticize the NRC. "CRAFT did not seek a waiver to allow it to challenge this regulation." Who knew we could get one? DTE's New Gas Scheme - Methane

"Renewable Natural Gas (RNG) is natural gas derived by capturing methane emitted from organic waste material in landfills, wastewater treatment plants and dairy farms. Methane gas is trapped and impurities are removed, creating a renewable source of pipeline quality gas," states the advertisement for DTE's new program Natural Gas Balance.

Ratepayers can choose to pay an extra \$4, \$8, \$12, or \$16 per month on their bills. Sounds to me like DTE's newest scheme to fleece us. For info, dteenergy.com/naturalgasbalance.

Sen. Peters likes Nukes?

We contacted Sen. Gary Peters to ask him to vote against the proposed American Nuclear Infrastructure Act and the nuclear waste storage plans. His responses seemed to have a fair amount of cut and paste:

"Nuclear power continues to be an important part of Michigan's energy mix, providing roughly 30 percent of our state's electricity." And:

"Hearing directly from Michiganders like you helps inform me of the issues that matter to our state. I am so grateful for your input."

The letters do differ in content, as the American Infrastructure Act tells us, "I have cosponsored the Nuclear Energy Innovation and Modernization Act to bolster research into advanced nuclear technology." That act passed into law.

The nuclear waste storage letter tells us, "I had serious concerns about the Canadian government's

proposal to build a permanent nuclear waste repository less than a mile from Lake Huron."

Both letters are dated January 28, 2021.

80-Years on Lake Michigan?

Last month, the NRC held a public comment meeting regarding NextEra Nuclear's (formerly Florida Power and Light) proposal to operate the two-reactor Point Beach nuclear power reactors in Two Rivers, Wisconsin for 80 more years.

The NRC and industry want the reactor licenses extended for 80 years, despite Unit 2 having the worst embrittled reactor pressure vessel in the country.

They are asking for this insanity on Lake Michigan, 21% of the world's fresh surface water, and 84% of North America's – the drinking water supply for 40 million people in 8 states, Canada, and Indigenous Nations.

Coalition Intervenes at Palisades

Terry Lodge, legal counsel for an environmental coalition (Beyond Nuclear, Don't Waste Michigan, Michigan Safe Energy Future, and Nuclear Energy Information Service) filed a Leave to Intervene and Request for Public Hearing with the Nuclear Regulatory Commission opposing the transfer of Palisades license from Entergy Nuclear to Holtec International.

The filing charges the license transfer would allow Holtec to drain the decommissioning fund for non-decommissioning expenses, and Holtec's underestimation of decommissioning costs.

The coalition also requests a Supplemental Environmental Impact Statement of the danger to Lake Michigan water. The sale would also include the Big Rock Point nuclear reactor which the NRC declared decommissioned although 8 casks of highly radioactive waste are still stored there.

Fermi's License Amendment #218


Last month, the NRC granted DTE a license amendment to "Change Surveillance Intervals to Accommodate a 24-Month Fuel Cycle."

"The amendment revises the technical specifications to increase certain surveillance requirement intervals from 18 months to 24 months to accommodate a 24-month fuel cycle," stated the document making legal Fermi's conversion to the new hotter fuel that will allow the reactor to go an extra 8 months without having to shut down for refueling.

However, the document states that "the affected calibration surveillance procedures will be revised as part of implantation, prior to the first 24-month cycle of operation." That one statement brings up two questions:

The NRC licensed a procedure that has not been revised yet? And didn't Fermi start its first 24month cycle this summer when it refueled and loaded the new hotter fuel?

"Based on its review, the NRC staff accepts that the reduction in safety is very small..." (still chipping away at our security?) and "The State official had no comments..." (the state never has, but unfortunately, we had expected better from Whitmer's administration)



Texas Grid Collapses in Storm

When the massive winter storm hit Texas last month, the governor blamed the president and sustainable energy. Neither was to blame.

The South Texas nuclear reactor was one contributor to the grid collapse when it filed to winterize its steam turbines, to save money, and frozen feedwater pumps caused a reactor SCRAM (the sudden shutdown of a nuclear reactor).

Other weather extremes that can cause SCRAMs include ice build-up on offsite electric utility lines which provide 100 % of the power to a reactor's safety systems.

The other extreme is prolonged heat that may make the cooling water temperature rise, causing shutdown – or a drought eliminating cooling water.

Taxpayers are funding Nuclear!

While most taxpayers are against nuclear energy, their elected officials are not. Last year, Congress approved \$1.5 **billion** just for research on producing new smaller reactors.

"Federal funding towards proven solutions like nuclear energy should continue," said a nuclear industry spokesperson, delighted about the money. "This will require the deployment of new nuclear designs and policies that preserve existing carbonfree nuclear plants."


